## On November 6 - Vote Yes on Question # 2 to Protect your Public Lands

Voting "Yes" for public lands on the ballot would ensure transparency and a higher standard to protect your public lands. If this ballot measure passes, the following would be required **BEFORE** the CT General Assembly could sell, swap, or give away your public lands:

- ✓ A public hearing; and
- ✓ A 2/3rds vote by the Legislature for State Parks and Forests, Wildlife Management Areas, state-owned agricultural lands, and other valuable state-owned public lands.

Your Yes vote is needed ... and your voice is needed. Please reach out to the voters you know who value public lands and legislative transparency and ask them to vote Yes on Question #2.



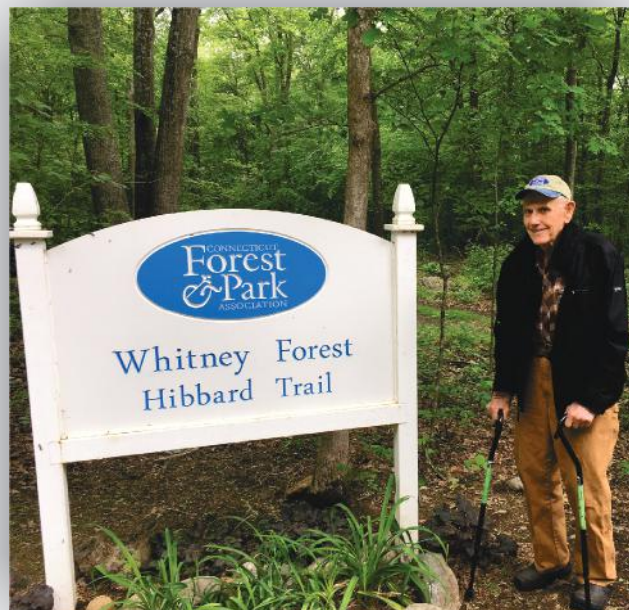
## Back to School

All things are connected in nature. Because of the decision to cultivate Milkweed in the CFPA gardens, we're helping to sustain the endangered Monarch butterfly.





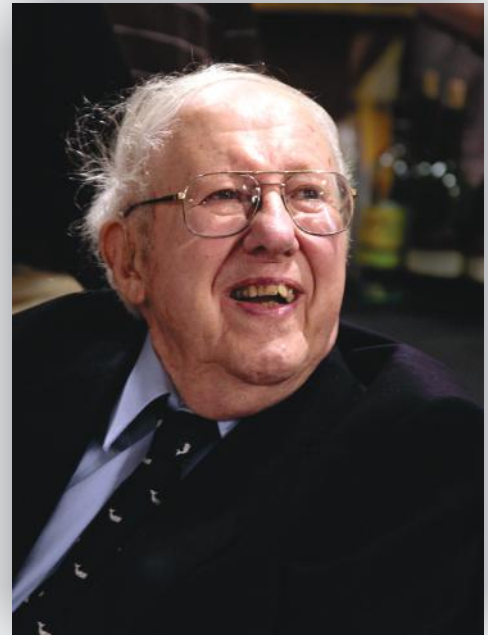
## Sam Dodd: a Legacy of Conservation and Service

Sam Dodd worked his entire life to preserve land and build trails. Sam was active, disciplined, and committed to his family and community. He and his wife Ann were busy and successful anesthesiologists. Sam founded Joshua's Trust, the largest land trust in eastern Connecticut. He considered his work with Joshua's Trust "to be the best thing he did."

Sam was also a CFPA Board Member for over 25 years and an Honorary Board Member afterwards. His legacy with CFPA will continue long after his death, and not just because of his service to CFPA.

Sam left a generous gift to CFPA in his will. The gift went into CFPA's Permanent Fund and will be an asset in protecting land and trails into the future.
